

Terms & Conditions: The Work and Travel Programme

(Please read and indicate your acceptance or non acceptance before signing terms and conditions)

This agreement is made on theday of20.....

BETWEEN Explore Your World Ltd, a limited liability company duly incorporated under the laws of Trinidad & Tobago with registered offices at 12 Marcus Park Tunapuna (hereinafter called "Explore Your World") of the ONE PART and (Name), with address.....

..... (Hereinafter called "prospective participant"), of the OTHER PART.

Whereas Explore Your World is a co-sponsor of The Work and Travel programmes to USA, England, and other selected Caribbean countries: and

Whereas Explore Your World is required to furnish its respective foreign co-sponsors, with funds for processing of applications of prospective participants by a specified date each programme year: and

Whereas Explore Your World is unable to recoup these funds in the event of cancellation by prospective participants after the specified date: and

Whereas Explore Your World requires the cooperation of participants to ensure the success and continuance of the programmes:

This agreement witnesses the following covenants on the part of (the participant):

1. That Explore Your World is not an employment agency and is therefore not responsible for securing employment for me and that I have no right to require, request or demand such unless I have paid the required fees.
2. That the Registration Fee is non refundable and non transferable.
3. That I will make all relevant payments and submit the required documents by the stated deadlines in order to be eligible to participate.
4. That if I make programme fee payments without submitting the required documents, I waive the right to full refund of such payment in the event of my non-participation which has been caused by my own failure or neglect to submit the required documents or for any other reason SAVE AND EXCEPT by reason of circumstances in Clauses 5,6 herein.
5. That I may exercise the right to cancel after submitting the documents and paying the programme fee with the understanding that the appropriate penalty will be deducted from any refund; also that notice of cancellation will be in writing and submitted to Explore Your World.
6. To abide by Explore Your World's absolute discretion in exercising its right to reject an application which fails to meet the programme eligibility criteria and /or is not considered to be in the general interest of the organization.
7. To understand and acknowledge that the relevant Embassy or High Commission has the authority to deny or approve the issuance of visa or entry clearance, and to be guided accordingly. I further understand that in the case of refusal, it is my responsibility to obtain the necessary document from the Embassy or High Commission and submit to Explore Your World in order to obtain a refund from Explore Your World. I also understand that in the case of the US programme that I will have to wait until Explore Your World has been refunded by the co-sponsor before I will receive a refund of the programme fee.
8. To allow Explore Your World first option to make all travel arrangements on my behalf for the programme.
9. To attend meetings, pre-departure orientation and post departure orientation where required.
10. To report physically to Explore Your World at the end of the programme period in which I participated (October 19) with my passport or immigration card and failure to do so will result in the invoking of the Indemnity Bond.
11. To report to the employer where I was placed, to perform my duties as assigned, to fulfill my legal obligation to ,programme sponsor (SEVIS registration). Further that I understand that the employer or myself can terminate my employment with at least two weeks written notice with copies to the programme sponsor. I understand that any violation of this clause can result in termination of my visa/deportation.
12. To conduct myself as a good ambassador- not to do anything that cast a poor image on my country, fellow students , myself or the programme. Further that if my behavior results in the cancellation of the programme that legal actions will be taken against me.
